CONDITIONS OF PLAY



All matches to be played 25 up. The tournament committee reserves the right to alter length of matches due to unforeseen circumstances.

Best 64 players from sectional play will advance to knockout draw

Best 64 players will be determined by wins, then shots up, then total shots

In the event of a player withdrawal, players remaining in that section of 2, will each be awarded a walkover win (with zero shots)

Scores over 25 do not count for shots up purposes

Qualifying rounds played in sections of 3

Restricting movement: Players will be allowed to visit the head after their 2nd, 3rd and 4th bowls.

First matches to begin at 11.00am sharp each day with a two end roll up before each match.

Players are allowed a maximum 30 minute break between games but are encouraged to begin matches as soon as possible.

During sectional play, players not playing are required to mark. Sections of only 2 players will be provided a marker.
